Technology tools for privacy compliance

- Intro: from paper to bits, from bits to big data changing what kind/size of data we process, we need to change the way we design, enforce and monitor compliance -- why digital/automated data management tools are becoming key for the legal and compliance department.
- What data? Data Discovery Solutions: surveying data "lockers".
- What do you do with data? Data Governance Solutions teaming up with product design to manage and monetise data assets?
- Users rights and IT infrastructures: Setting up policies and tools to address users requests to access, portability, RTBF, etc Enforcing retention and deletion policies in practice.
- Real world issues and tech solutions (consent/marketing): Clean data vs "dirty" data; keeping track of marketing consents and lawful communication to data subjects.
- The evolution of checklists: Self-audit tools and data visualisation dashboards to verify compliance and retain dynamic documentation in shifting data landscape.
- What DPAs make of all of this? Best practices, innovation, new tools are a good investment? Would DPAs support this evolution and reward tech compliance?

Avoiding roadblocks to doing technology and data business in China

This roundtable will discuss the legal framework and policies on foreign investment in China in relation to the technology sector, with a focus on TMT and telecoms, which are still restricted or prohibited.

It will look at how the cybersecurity law impacts companies doing business in China (e.g. information service providers such as cloud services, AI companies who collect and use data, healthcare and pharmaceutical companies who collect and transfer patient data, transport companies using online maps and other sensitive information, and financial institutions and retailers who gather and use personal data).

It will also address blockchain applications in China and related government policies and restrictions.
