### ugo Sinzheimer Moot Court Competition



From 13 until 15 June 2019, approximately 100 ambitious people will be gathering in Hasselt for the fourth edition of the Hugo Sinzheimer Moot Court Competition (HS MCC).

Hasselt University's Faculty of Law is proud to host the event and is happy to meet you all for three fun days of intensive pleading.

The aim of the HS MCC is to deepen and improve the knowledge of employment and labour law at the European level. It offers students an opportunity to experience European law in a setting that is as realistic as possible.

Every year, this event is hosted in another country. The first HS MCC took place in June 2016 and was hosted by the Hugo Sinzheimer Institute in Amsterdam, the Netherlands. After Aarhus University (Denmark, 2017) and the University of Cassino (Italy, 2018), the competition's fourth edition is hosted by Hasselt University, Belgium from 13 to 15 June 2019.

# A bout Hugo Sinzheimer

The competition is named after the German scholar and lawyer Hugo Sinzheimer (1875-1945), who is internationally considered the founding father of labour law. His ideas and publications have had a profound impact. Sinzheimer, who united various perspectives on labour law, stands for the concept of Social Labour Law.

Sinzheimer, who held a PhD in Law and Economics from the University of Heidelberg, later became an honorary professor of Labour Law and Sociology of Law at the University of Frankfurt in 1933. Being Jewish, Sinzheimer was forced to flee to the Netherlands. He immediately obtained a professorship in Sociology of Law at the University of Amsterdam, which in 1936 was followed by a second professorship in Leiden.

As a member of the Weimar National Assembly, Sinzheimer was also actively involved in the construction of the Weimar Constitution, which



contained rights regarding freedom of association and employee participation.

From 1993 onwards, the Hugo Sinzheimer Institute of the University of Amsterdam has been named after this great lawyer. In 2010, a Hugo Sinzheimer Institut für Arbeitsrecht was also founded in Frankfurt am Main, Germany. The Hugo Sinzheimer Moot Court Competition is institutionally embedded within the Hugo Sinzheimer Institute at the Law School at the University of Amsterdam.



Hasselt University is an innovative university, which has a pronounced international orientation. Founded in 1971, it is the youngest university in Belgium. Hasselt University stands for excellence in education, top research in spearhead fields and active commitment to innovation and entrepreneurship. The overall objective is to combine academic excellence with economic and social relevance.



The Faculty of Law retains a young, though experienced staff. Its law programme focuses on international and European law, judicial protection and mediation, and provides a platform for the comparison of European and various national legal systems. The emphasis on international and public law is unique. Thanks to problem-based learning (PBL), graduates from the Law Faculty at Hasselt develop skills that are particularly useful for their careers. Maastricht University and KU Leuven, renowned for their academic traditions, are both partners to the programme.

#### A different perspective on law

Problem-based learning clearly illustrates the innovative character of the law programme at Hasselt University. PBL is a method of teaching that finds its origins at Maastricht University, one of the partners of the law programme at Hasselt. In a PBL environment, students are personally responsible for their academic education. In small tutorial groups, they analyse problems, have discussions, exchange knowledge and formulate their learning goals as a group. This motivates them to engage in research themselves.

By actively addressing a number of issues, students manage to grasp the theory and learn to apply their insights to various questions. Differing views enliven discussions and allow students to experience the true strength of the group's diversity. Moreover, students gain essential skills, such as how to present opinions, how to debate, how to write texts and how to work together.

#### Skills that last a lifetime

PBL is effective: Hasselt law graduates are assertive, independent and expert professionals. They are skilful in analysing complex issues, collecting and structuring information, working in international teams, conducting and leading discussions, and in creating and presenting ideas.







#### Hasselt University

Hasselt University is a young and innovative university. Founded in 1971, it is the youngest university in Belgium.

Approximately 6000 students, 600 PhD students, and 1300 staff members are connected to Hasselt University. The faculties of Sciences, Engineering Technology, Medicine and Life Sciences, Rehabilitation Sciences, Business Economics, Law, and Architecture and Arts offer attractive undergraduate, graduate and PhD programmes at a high academic level.


#### YUP Hotel




#### Closing Dinner Saturday 15 June 2019, 19:30 – 21:30

#### Anne Marie De Rieck (Belgium)

Anne Marie De Rieck studied law at the University of Leuven

(1986-1989) and started her career as a lawyer in Leuven, until 2005. Afterwards she became a judge at the labour court. In 2011, she became the president of the labour court of Antwerp, responsible for the departments Hasselt and Tongeren.



#### Filip Dorssemont (Belgium)

Filip Dorssemont is Full Professor of Labour Law at the Université Catholique de Louvain and visiting

Professor at the Vrije Universiteit Brussel. He studied Law and Philosophy at the Universities of Antwerp and Leuven. From 1993 to 2002, he was assistant, doctorassistant and lecturer at Antwerp University. Later he became researcher and lecturer at Utrecht University. In 2008, he was able to return to his home country owing to a Programme of Academic Mobility of the FNRS. Filip Dorssemont also taught European labour law at the Università Statale di Milano (2008-2011) and was a visiting Professor at Strasbourg University and Bordeaux University. His fields of research are labour law, industrial relations, European Union labour Law, fundamental workers' rights, Art and labour.



#### Annemie Janssens (Belgium)

Annemie Janssens studied law at the University of Antwerp. She started her career as a lawyer in 1986.

In 1990 she was appointed as an intern with the public prosecutor of the first instance Court in Antwerp. Three years later she was appointed as a judge of the labour court in the same city. In 2014 she became the president of the labour court of Antwerp and her mandate was renewed for another five years in 2019.



Iris Haanappel-van der Burg (The Netherlands)

After studying law at Leiden University (1991-1996), Iris

worked as a lawyer for thirteen years, mainly in labour law (Andersen Legal, AKD and Philips). Subsequently she wrote a PhD at the University of Amsterdam on Cross border transfer of undertakings from a comparative and conflict of laws perspective (2010-2015). After obtaining her PhD, Iris worked as an assistant professor in labour law at Leiden University. Since January 2018 Iris has been working as a judge (in training) at the Court of Appeal in Amsterdam, mainly in labour law.

#### Miriam Kullmann (Austria)

Miriam Kullmann is an assistant professor at WU Vienna University of Economics and Business. As

a guest researcher, Miriam is also affiliated with the Business and Law Research Center at Radboud University Nijmegen and with the Department of Labour and Social Security Law at Leiden University. Miriam holds a PhD from Radboud University Nijmegen in European and comparative labour law. Before joining WU, she worked as a legal assistant at Leiden University on a European Commission funded project, the European Labour Law Network, and as an assistant professor at Maastricht University. Miriam currently researches the potentials and challenges that exist with algorithmic (and machine learning) discrimination in the platform economy and in job application processes.



#### Elmiira Kutvonen (Finland)

Elmiira Kutvonen is an associate lawyer in the Employment & Benefits practice of Roschier, a

leading Nordic law firm. Roschier's Employment & Benefits practice is top-ranked by major international legal directories and serves corporate clients in a wide range of employment law issues. She was a member of Team Finland, the winner of the Hugo Sinzheimer Moot Court Competition in 2017.



#### Ulla Liukkunen (Finland)

Ulla Liukkunen has published widely on labour law, private international law, comparative

law, transnational law and the governance of the social dimension of globalization. She has led two Academy of Finland international research projects, has broad experience in drafting national and EU law, and has acted as an expert in several international projects on labour law. Her most recent/coming publications include Collective Bargaining in Labour Law Regimes – A Global Perspective (ed; Springer 2019); Employment and Private International Law (ed; Elgar, forthcoming 2019) and Enclave Governance and Transnational Labour Law – a Case Study of Chinese Workers on Strike in Africa (together with Yifeng Chen, Nordic Journal of International Law, forthcoming 2019).



#### Jari Murto (Finland)

Jari Murto is an assistant professor of labour and social law at the University of Helsinki. His main

research interest is the determination of terms of employment.



Emanuele Menegatti (Italy)

Emanuele Menegatti is Professor of Labour Law and Dean of the School of Economics and

Management at the University of Bologna. He has published two books and numerous articles in the field of comparative, EU and Italian labour law. He is the co-editor of the books Labour Law and Industrial Relations in Italy and The Sources of National Labour Law in Contemporary Economy (forthcoming). He is the editor-in-chief of the new edition of the Italian labour law e-journal.



#### Ana Teresa Da Silva Ferreira Ribeiro (Portugal)

Ana Teresa Ribeiro is, since 2011, a Lecturer at Porto Faculty of Law

- Universidade Católica Portuguesa. She is currently finishing her PhD thesis, on the subject of collective bargaining, and her main areas of interest are Labour Law, Constitutional Law, and Fundamental Rights. She has published several articles and book chapters, both in English and Portuguese, and has also, participated as a speaker at various conferences.

### Jorma Saloheimo (Finland)



Jorma Saloheimo is the former President of the Finnish Labour Court, retired in 2018, Before his

recruitement in the Judiciary in 2001, he acted as a researcher and professor of labour law mainly in the University of Helsinki. He served with the ILO in Geneva from 1972 to 2005, where he inter alia held positions as Deputy Regional Director for Asia and the Pacific, Research Coordinator at the International Institute for Labour Studies, and Director of Operations at the ILO Regional Office for Arab States. He is the author of numerous books and articles in the field of international and comparative labour law and industrial relations.



Joanna Unterschütz (Poland)

Joanna Unterschütz is an Associate Professor in the Chair of Labour Law and Social Security at

the University of Business and Administration in Gdynia, Poland. She is the author of publications in the fields of national and European labour law, criminal labour law including human trafficking. She has also participated in several international research projects, focused on the protection of fundamental rights and labour law and is a member of the Transnational Trade Union Rights Experts Network (TTUR), a network of lawyers from various European countries, which focuses on the study of European labour law and social rights. Her co-operation with the Polish Institute for Human Rights and Business (an independent and impartial think tank offering advanced expertise in Human Rights and Business) is focused on human rights and employment conditions in Polish shipyards.



#### Hannele Vettainen (Finland)

Hannele Vettainen works as a lawyer in the Finnish Confederation of Professionals

STTK, specialized in labour legislation. She is also a member of the Labour Court of Finland. STTK is an independent and pluralistic labour market organization with 15 member organizations and over 500000 members

#### Manfred Weiss (Germany)

Manfred Weiss is the chairperson of the Advisory Board of the Hugo Sinzheimer Moot Court

Competition. He is Professor emeritus of labour law and civil law at Goethe University in Frankfurt and has inter alia been President of the International Industrial Relations Association (IIRA), consultant to the ILO and consultant to the Commission of the EU. He is an honorary professor of the University of Cape Town as well as an extraordinary professor of NWU, University of Stellenbosch and UWC. He is the author of numerous books and articles in the field of labour law, European labour law, and industrial relations. In 2015, he received the LLRN-Award for outstanding contributions to labour law.





We thank you all for being here, and we hope to meet you again in the future! I would like to praise the colleagues, organisers, coaches, judges for their excellent work.


