ABOUT THE ECSL

The European Centre for Space Law (ECSL) was established in 1989 under the auspices of the European Space Agency (ESA) and with the support of a number of pioneers in this field. It is founded on the basis of a Charter, last amended in 2009.

ECSL's main objective is to develop and promote an understanding of the legal framework relevant to space activities. The ECSL meets this objective by fostering the exchange of information and encouraging the teaching of space law.



ECSL's structure is flexible and open. Its General Meeting of Members takes place every three years and is responsible for electing the ECSL Board. 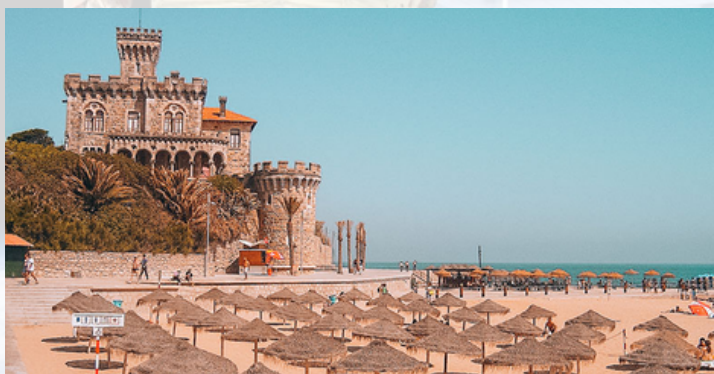

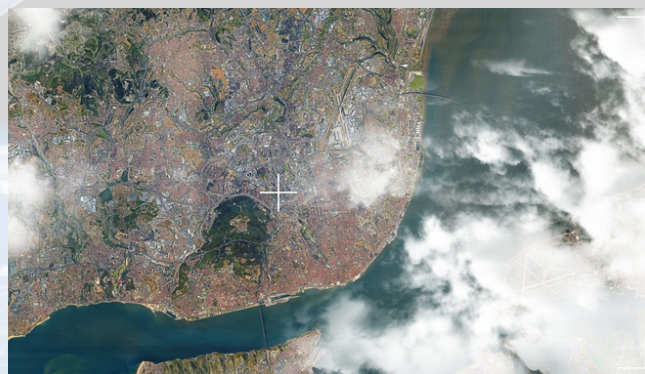

ALEXANDER SOUCEK

Alexander Soucek is the Head of the Public International Law Division of the European Space Agency (ESA). He serves as the Secretary of the International Space Station Coordination Committee and the legal advisor of ESA's International Relations Committee. He represents ESA in the Legal Subcommittee of the UN COPUOS. Alexander earned degrees in law from Salzburg University, Austria, and in space studies from the International Space University in Strasbourg, France.



Alexander is an alumnus of the Hague Academy of International Law Centre for Studies and Research, a former visiting researcher at the Space Policy Institute, George Washington University, and a former research assistant in international law at Salzburg University. He lectures on space law and the law of international organisations and published books, commentaries and articles on space law. He is a corresponding member of the International Academy of Astronautics, a member of the International Institute of Space Law and of the European Centre for Space Law, and serves as a Director of the World Space Week Association. From 2003-2020, he also served as a member of the Executive Board and president of the Austrian Space Forum.



ARMEL KERREST

Armel Kerrest is Emeritus Professor of Public Law in the French Universities, having taught International Public Law, especially Space Law and Law of the Sea at the Universities of Western Brittany and Paris XI. He has taught at the ECSL Summer Course since its inception and has authored multiple publications.

Armel has supported the Manfred Lachs Space Law Moot Court Competition for twenty years. He has been an advisor for Space Law for multiple international organisations, governments and private companies. He serves as the Vice-Chair on the ECSL Board, as President of the Association for the Development of Space Law in France and as Chair of the Institute of Law of International Space and Telecommunications (Brittany). Armel is a member of the Space Law Committee of the International Association (ILA), the International Institute of Space Law (IISL), the Société Française de Droit Aérien et Spatial (SFDAS) and a member of the Académie de l' Air et de l' Espace.

BALÁZS BARTÓKI - GÖNCZY

Balázs Bartóki-Gönczy is a law graduate of Pázmány Péter Catholic University (PPKE) in 2010, Panthéon-Assas Paris II and Paris Saclay, where he specialised in telecommunications and space law. He has an MBA Degree from Lyon III university and has successfully defended his PhD at the Doctoral School of Law and Political Sciences of the Pázmány Péter Catholic University, specialising in legal and regulation issues of online platforms.



Balázs has taught at the University of Public Service (NKE) since 2018 as an associate professor. He is Head of the Outer Space and Social Sciences Research Group and Head of Department of Social Communication - Faculty of Public Governance and International Studies. Prior to working at NKE, Balázs worked as Project Manager at the National Media and Infocommunications Authority of Hungary (NMHH).

His research area is electronic communications law, new media law and space law which he teaches in Hungarian, English and French. Balázs teaches at Pázmány Péter Catholic University Faculty of Law and Political Sciences as well as the University of Public Service. He was recently elected as a member of the Media Council by the Hungarian National Assembly on 14 December 2021.

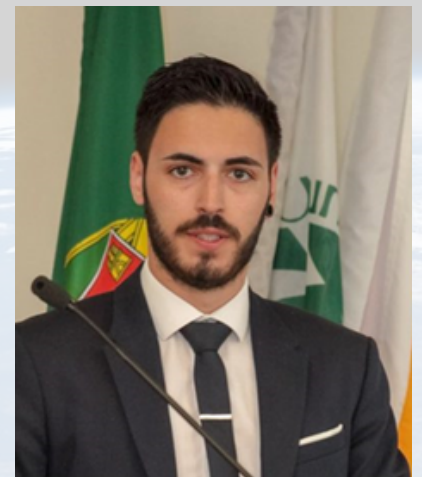
GEORGIOS CHATZICHARALAMPOUS
